#### **Enrolments**

Enrolments remain high with good demand across all areas. Semester 2 applications are tracking well. We are currently at 113.4% of our allocated TEC funded EFTs, and 111% of our international budgeted EFTS. We are 810 EFTS ahead of budget.

#### **Industry Visits**

On the 13<sup>th</sup> May I met with Sarah Ramsay from United Machinists around how we better meet their needs for employees. We are trialling a degree apprenticeship pathway with our mechanical engineering students to allow them to specialise in high end engineering. Three first year Bachelor of Engineering Technology students are now completing their degree apprenticeship with United Machinists and will be learning and earning at the same time, this will be evaluated every 6 months from the perspective of the learner and the employer.

This was followed with a visit from Ceri McLeod from Southland and Otago Regional Engineering Collective (SOREC) and Ivan Hodges from the Ministry of Education around new pathways, professional development opportunities and transitions from school to tertiary education – all focused on manufacturing and engineering.

I met with Jason Tibble Regional Commissioner for the Ministry of Social Development (MSD) and the Senior Official for Central Government in the Lower South Island. The purpose of this was to ensure that we are providing a coordinated approach for supporting our community and creating pathways from MSD services for prospective learners.

I attended the Mayoral Dinner on the 8<sup>th</sup> June to welcome the New Zealand and Australian-based ambassadors visiting Dunedin, as part of the Ministry of Foreign Affairs and Trade's 2021 Study Tour. On the 9<sup>th</sup> June Barry Law presented what we have been doing with Whaiao – RCE Otago to this group also.

#### **Key Points:**

- The net operating surplus of \$4,840k is favourable to budget by \$2,055k mainly due to additional student income from increased enrolments.
- Extraordinary income relates to the grant for the shovel ready building project, the timing of this income has changed since budget.
- Capex is lower than budget to date by a net \$3,871k due to timing of the shovel ready building project.
- Net Monetary Assets are currently favourable by \$1,419k, mainly due to the timing of the shovel ready building costs.
- EFTS enrolments of 5,094 are favourable to YTD budget by 661. This is due to additional enrolments across multiple programmes.

- Coverage reached a cumulative audience of 2.81 million.
- Online News had the highest volume of coverage (92 news mentions)
- The outlet with the highest volume was Otago Daily Times with 68 mentions

#### Key themes of coverage:

Otago Polytechnic is in the early stages of making plans to set up a "work-based learning facility" called Dunedin School of Games in the Central City with the aim for students to become immersed in Dunedin's growing gaming sector.

Learners and their families had a chance to come and see the Otago Polytechnic campus for Tertiary Open Days held on 23 and 24 May which included tours, seminars, and expos.

A move to bolster the city's reputation as world class in veterinary science and wildlife ecotourism sees Otago Polytechnic looking towards the creation of a purpose-built wildlife hospital and visitor centre in Dunedin. This would be with help from the DCC and a fundraising programme.

A cohort of first year Otago Polytechnic Bachelor of Design (Communication) learners have had their work acknowledged in Kātoitoi, the Aotearoa Design Archive. This was for their Covid-related work "Lockdown Zines".

The inaugural Dunedin Schools Games Jam was hosted by Otago Polytechnic Centre of Digital Excellence as part of Techweek 2021. Year 12 and 13 high school pupils designed and coded their own games over a weekend and were mentored by local from the game industry alongside staff and senior students from the BIT programme.

#### **OP WEBSITE**

There were more than 557K page views in the past month. New website visitors comprised approx. 24.34% of traffic (the remainder were returning visitors); the average time spent per view was 2min 26sec.
